The Company has a loan facility provided by Bizzell Nominees Pty Ltd an entity associated with the Company Chairman. The facility is for up to \$2 million, interest rate on drawings is 10% and the facility is secured by a fixed and floating charge over the assets of the Company.

Maroon Gold Pty Ltd has provided an interest free unsecured loan facility to Laneway, as part of an agreement for mining operations at Agate Creek and processing of ore through Maroon's wholly owned CIL processing plant, for an amount of up to \$500,000 to meet costs to be incurred to complete the process for the Mining Lease grant at Agate Creek including Native Title and Landholder obligations, tenement holding costs and environmental liability financial assurance requirements. The loan balance at the end of the quarter was \$146,550.
