<p>The Company has a loan facility available to it provided by Bizzell Nominees Pty Ltd an entity associated with the Company's Chairman. The facility is for up to \$2 million, interest rate on drawings is 8% and the facility is secured by a fixed and floating charge over the assets of the Company. The balance at the end of the quarter was \$nil.</p> <p><sup>1</sup> The short-term loan facility (of up to \$2m) is repayable to Laneway by 30 September 2020. Interest receivable on the funds advanced is at 8% per annum. The loan has been advanced to BAM Opportunities Fund Pty Ltd and enables Laneway to be able to generate an enhanced return on surplus cash held and is secured by a first ranking fixed and floating charge over the assets of the borrower. Laneway received an interest payment of \$51,293 during the quarter with respect to this facility. Subsequent to the end of the quarter, Laneway has also received loan repayments of \$175,000.</p>
