In addition to the loan facility noted above the Company is being funded in relation to exploration being undertaken on its New Zealand tenements in accordance with a farm-in agreement with Newcrest Limited whereby Newcrest will solely fund two stages of Minimum Work Programs associated with the Permits, with the first stage forming a Minimum Commitment;
