<p>Answer: No – the September 2021 quarter included one significant payment of \$1.474 million in relation to mining operations undertaken in the prior financial year. No payment of this quantum is expected in the current period. The Company has also recently recommenced mining operations and expects to generate positive cashflow from these activities.</p>

Answer: The Company has access at the end of the quarter to over \$2 million to fund its operations from amounts undrawn on a loan facility . This is expected to be sufficient to meet expenditure requirements until proceeds from current mining activities are received.
